If your Qualified Referral\* friend engages to take our services, AukSun will send you US\$100.

Your earnings will automatically be sent to you with an acknowledgement via email.

## Refer-a-Friend Terms & Conditions

1. Refer-a-friend program is in effect from 1<sup>st</sup> January 2004 until further decision.
2. AukSun reserves the right to cancel the Refer-a-Friend Program or to change these terms and conditions at any time in its sole discretion.
3. A Qualified Referral is defined as the person who is introduced by an already existing member/client of AukSun and who has not previously acquired our services and who engages our services via Refer-a-Friend Program. Only one Qualified Referral of US\$100 can be earned for each Referred Client. Any additional or subsequent services acquired by a Referred Client will not be Qualified Referrals.
4. The individual who was an Associate, Member or Existing Client of AukSun will be considered to be the "Referring Client" for all Qualified Referrals made using that relationship, regardless of whether a Referred Client obtained the Personal Link directly from the Referring Customer or from another source.
5. For each Qualified Referral, up to the annual maximum number of Qualified Referrals allowed, a credit will be deposited in the Referring Client's account of the Referring Customer within twenty (20) days after the Referred Client deposits his/her consulting fees. Agreements cancelled by the Referred Client prior to submitting the consulting fees do not qualify under this program
6. A Referring Customer can earn amounts for no more than ten (10) Qualified Referrals per calendar year.
7. Unless otherwise specifically stated by AukSun, a Referred Customer may use any discounts or promotions associated at that time only for the Referred Customer's initial transaction.
8. **If a Referring Customer provides a Personal reference to another person by email, the email must be created and distributed in a personal manner that is appropriate and customary for communications with friends and family members. Bulk email distribution, distribution to strangers, or any other promotion of a Personal Link in a manner that would constitute or appear to constitute unsolicited commercial email or "spam" under any applicable law or regulation is expressly prohibited and will be grounds for immediate termination of the Referring Customer's account.**
9. The amount earned for Qualified Referrals is subject to change by AukSun at any time without advance notice.
10. The amount earned is not transferable
